The cutting laser is part of a large investment package with which Witzenmann is making the Zwickau location fit for the future. This also includes the construction of a new administration building. The start of construction is planned for this year.

The pipe supports are used in large process engineering plants, secure the pipe systems weighing several tonnes and absorb movements and load changes. With the modern cutting laser, individual parts for the pipe supports are cut to size precisely, efficiently and in a resource-saving manner.

In the course of its strategic transformation, Witzenmann is sharpening its profile and bundling industrial competences at specialised locations.
